IN 2016, AATN GATHERED THE EFFORTS OF TRUST (TRAINING AND RESOURCES UNITED TO STOP TRAFFICKING), AZMEN (ARIZONA MEN), AND CSI (COMMUNITY SCHOOLS INITIATIVES) TO BRING ATTENTION AND AWARENESS TO THE PROBLEM OF HUMAN TRAFFICKING IN ARIZONA. IN ADDITION TO COMMUNITY EDUCATIONAL ACTIVITIES, OVER 150 LAW ENFORCEMENT OFFICERS, FIRST RESPONDERS, AND PROBATION/DETENTION PERSONNEL WERE SPONSORED TO ATTEND A SHARED HOPE REGIONAL CONFERENCE IN MESA IN JUNE. FIFTEEN (15) MIDDLE SCHOOL YOUTH WERE PROVIDED AFTER SCHOOL PROGRAMS TO ADDRESS SIGNS OF TRAFFICKING, SELF-ESTEEM ISSUES, AND HOW TO AVOID PREDATORS ON-LINE. FOUR QUARTERLY COMMUNITY EDUCATION MEETINGS WERE HELD FEATURING KNOWLEDGEABLE SPEAKERS FROM NATIONAL ORGANIZATIONS SUCH AS POLARIS TO ADDRESS THE LOCAL ISSUE OF TRAFFICKING. THREE HIGH LEVEL LOCAL GOVERNMENT OFFICIALS WERE SPONSORED TO TRAVEL TO WASHINGTON, DC FOR A NATIONAL TRAFFICKING CONFERENCE.

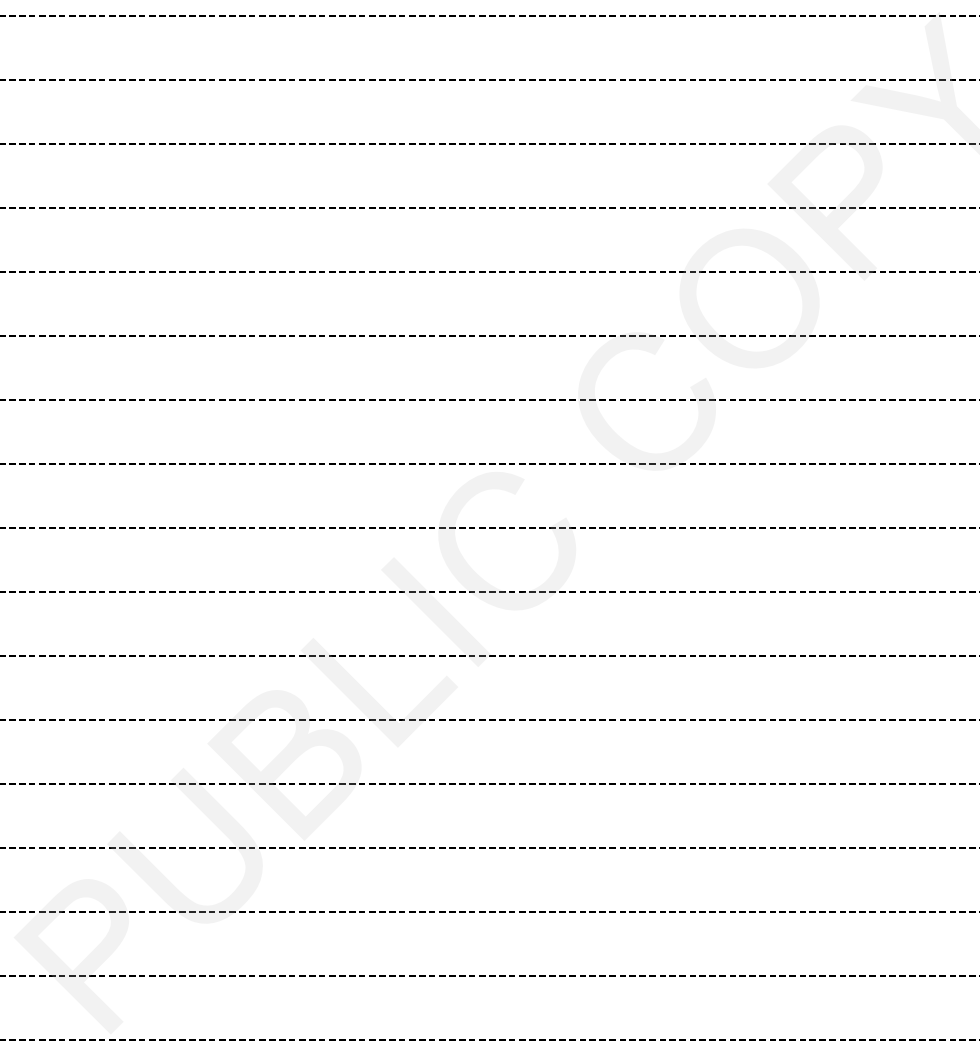
