AATN HAS GATHERED THE EFFORTS OF TRUST (TRAINING AND RESOURCES UNITED TO STOP TRAFFICKING), ALWAYS (ARIZONA LEGAL WOMEN AND YOUTH SERVICES), AZMEN (ARIZONA MEN), AND CSI (COMMUNITY SCHOOLS INITIATIVES) TO BRING ATTENTION AND AWARENESS TO THE PROBLEM OF HUMAN TRAFFICKING IN ARIZONA. IN ADDITION TO COMMUNITY EDUCATIONAL ACTIVITIES, OVER 200 LAW ENFORCEMENT OFFICERS AND FIRST RESPONDERS HAVE BEEN TRAINED TO RECOGNIZE THE SIGNS OF TRAFFICKING, AND OVER 75 OF OUR MOST VULNERABLE YOUTH WERE PROVIDED PRO BONO LEGAL SERVICES IN FAMILY AND CIVIL COURT.
